

Vendor Contract

Sedro-Woolley Founders' Day will be held September 12th in Sedro-Woolley, Washington at Riverfront Park.

Sedro-Woolley Chamber and Founders' Day Committee does not make any specific guarantees as to the number of attendance for this event. There are no refunds, including but not limited to Acts of God.

1. By signing this contract the vendor agrees to pay the specified booth rental fee of \$25. All checks will be payable to the Sedro-Woolley Chamber of Commerce.
2. All applications and appropriate fees must be turned in no later than September 8, 2010.
3. Vendor agrees to indemnify and hold harmless: The City of Sedro-Woolley, Skagit County, Sedro-Woolley Chamber and Founders' Day Committee and the staffs and boards of these organizations against any claim or action for any cause. Vendor agrees that they will be responsible for their own insurance under this hold harmless clause, which is part of this contract.
4. Vendors must list items they will be selling, distributing, advertising or promoting. Merchandise or other materials being sold, promoted, displayed, given away or marketed shall be conducted within the designated space rented by the vendor.
5. Any materials the Sedro-Woolley Chamber and Founders' Day Committee deems obscene, dangerous, unlawful or otherwise inappropriate for a family friendly environment is strictly prohibited from sales, promotion and display or advertised in anyway. No, Alcohol, drugs, or firearms are permitted.
6. All merchandise belonging to anyone will be the sole responsibility of the owner. The City of Sedro-Woolley, Skagit County, Sedro-Woolley Chamber and Founders' Day Committee will not be responsible for missing or damaged property.
7. Each vendor will be responsible for keeping their area free of trash and debris within and immediately around their individual spaces and when each vendor removes their equipment, merchandise and materials from their space at the conclusion of the event.
